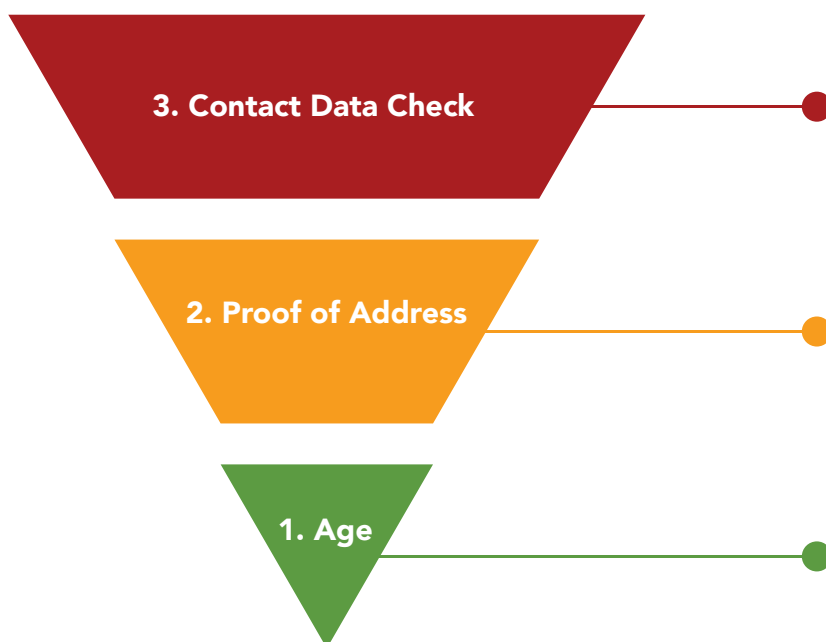
### Melissa Patient Verification service helps to answer:

### Melissa Patient Verification: A Layered 3-2-1 Approach

Patient verification uses a layered 3 – 2 – 1 traffic light approach of contact data quality verification, proof of address, and age verification to confirm the individual’s identity and their approval for care.



#### 3. Contact Data Check

Melissa employs a data quality verification layer that verifies each piece of the contact data - name, address, email, phone - before it gets passed to the next step.

#### 2. Proof of Address

Once contact elements are verified, ensure the person actually lives at the provided address. Melissa’s service connects a person’s name to a specific address to confirm proof of address in real time. Checks are made against government, credit agency, and other trusted sources.






#### 1. Age Verification

Melissa’s service performs a date of birth check and a deceased register check to ensure the individual is age appropriate for the course of action and is not someone who has assumed an identity of a person who is deceased.
